### **Program Eligibility:**

- Ambitious and well-rounded students with a demonstrated readiness to secure an internship
- At least a **3.2** cumulative UCLA GPA (incoming transfer students are eligible with transfer GPA)
- Intended for **juniors** who expect to graduate between December 2017 and June 2018. Incoming transfer students, sophomores who will graduate early are eligible to apply.
- Available for at least 10 weeks during Summer 2017(**required**)

  - 1-page **Resume**
  - **Cover Letter** addressed to the "Sharpe/Simon Fellows Selection Committee" specifying your career interests, relevant background and qualifications, and your interest in the Sharpe Fellows program
  - 1-page, double-spaced, **personal essay** describing "your outside interests and any life experiences that set you apart as one of UCLA's best"
